1. Trustees: Trustee Welty attended the 27<sup>th</sup> International Congress of Entomology in Kyoto, Japan. He expressed his gratitude to the Board for allowing him to attend this event and noted that networking and/or connections that the District Manager has with international scientists are very important. It was apparent that there are two sides to many of the topics which the manager shared in real time or after the meeting.

Trustee Su provided a brief presentation on his recent trip to the 27<sup>th</sup> International Congress of Entomology in Kyoto, Japan with participants from 82 countries and regions. The Crown Prince and Princess of Japan attended the event as well. Trustee Su shared presentation topics like The Global Bed Bug Resurgence, Biology and Management of Container-inhabiting *Aedes* Mosquitoes, and Epidemiology of Japanese Encephalitis.

2. District Manager: Thanked the District and the Trustees for attending the 27<sup>th</sup> International Congress of Entomology in Kyoto, Japan. The District Manager reflected on the potential new mosquito-borne viruses being introduced to SoCal and revisiting the risk and the introduction of Japanese Encephalitis. Lastly, the District Manager shared his attendance at the City of Corona Council Meeting and provided a brief update regarding the progress of the 5-Year Strategic Plan.

3. Staff: Public Information & Tech. Officer provided a brief presentation to the Board on the drone application trial in Lake Elsinore from Leading Edge that incorporated Central Life Sciences partnering with the District.

The Clerk of Board/HR Generalist conveyed the District reached 365 days without an employee injury leading to lost work time. In celebration of reaching that goal, the District will provide an employee lunch. In addition, work


